**Agenda Item 6: Unfinished Business:**

**6.1 Discussion of Local Option Levy(Police)**

Staff presented the information requested by the Council regarding the local option levy and options for the use of any increased revenues requested. Several options were presented showing revenues at different levels and uses of those revenues. After considering the information, Council directed staff to return at the next meeting with the appropriate resolutions and paper work to submit the local option levy to the voters in King City at the November election this year at a rate of \$.55 per thousand dollars of assessed valuation. The council felt strongly that the increase of \$.1315 per thousand would allow the Police Dept to better serve the community by increasing patrol and supervision, providing for the upgrade of aging equipment and maintain service levels in the future.

### **7.1 116<sup>th</sup> Avenue Reconstruction Project**

Staff presented the bid results for the above noted project. All bids received were below the Engineers estimate of \$335,000. The City Engineer recommended the award of the bid to Brix Paving Co. in the amount of \$216,639.48.
